ADULT/MINOR CONTESTANT RELEASE

We the undersigned, hereby request that the named minor be granted permission (1) to enter the restricted area (2) participate as a participant, assistant, official, or other wise rodeo events, (3) to compete for money, prizes, recognition or award, (4) to be covered by participants: hospitalization insurance, if applicable, as limited by the master policy. (All collectively hereinafter called "permissive entry").
In consideration of "permissive entry" to minor participant into the restricted area which is the area from which admission to the general public is restricted, which includes, but is not

limited to the rodeo arena, competition area, chutes, pens, adjacent walkways, concessions, and other appurtenances, we, the undersigned, on behalf of the minor and or spouses and assigns, do hereby;

- 1. Release, discharge and covenant not to sue the rodeo committee, stock contractor, rodeo association, sponsors, arena operators or owners and each of them their officers, agents and employees (all hereinafter collectively as "releasees") from any and all claims and liability arising out of strict liability or ordinary negligence of releasees or any other participant which causes the undersigned injury, death, damages of property. We, the undersigned, jointly, severally, and in common, covenant, to hold releasees harmless and to indemnify releasees from any claim, judgement or expenses releasees may incur arising out of any of the minors activities or presence in the restricted area.
- 2. UNDERSTAND that minors entry into the restricted area and/or participating in rodeo events contains DANGER AND RISK OF INJURY OR DEATH TO MINOR that conditions of the rodeo arena change from time to time and may become more hazardous that rodeo animals are dangerous and unpredictable and that there is INHERENT DANGER in rodeo which we each appreciate and voluntarily assume because the minor and we choose to do so. Each of the undersigned has observed the events of the type that the minor seeks to participate in. We further understand that the arena surface access ways or lack thereof, lighting or lack thereof, and weather conditions all change and pose a danger to the minor, but nevertheless, WE EACH VOLUNTARILY ELECT TO ACCEPT ALL RISKS connected with the minors entry into the restricted area and/or participation in any rodeo events.
- 3. AGREE that this agreement shall apply to any incident, injury, accident or death occurring from the date below FOR A PERIOD OF ONE(1) YEAR THEREAFTER or until the association membership expires, whichever shall last occur. All subsequent agreements and release documents signed by any of the undersigned shall amplify, but shall in no way limit the provisions of this document The provisions of this document may be cancelled by anyone undersigned by delivering to the above Evanston Rodeo Series written cancellation of this agreement which shall be effective 24 hours after the date signed cancellation is actually received by the Evanston Rodeo Series.

 4. RELEASOR or parents or guardians of the assigned minor, AGREE TO INDEMNIFY the releasee and each of them from loss, liability, damage or costs that they may incur due

to the presence or participation of the minor in the described activities whether caused by negligence of the Releasee or otherwise.

TO ALL ADULTS: WE HAVE READ THIS DOCUMENT, WE UNDERSTAND IT IS A RELEASE FOR ALL CLAIMS. WE APPRECIATE AND ASSUME ALL RISKS INHERENT IN RODEO. BY SIGNING BELOW WE AGREE NOT TO HOLD THE EVANSTON RODEO SERIES, UINTA COUNTY, UINTA COUNTY FAIR BOARD, CITY OF EVANSTON, SPONSORS, VENDORS AND PERSON INVOLVED WITH THE PRODUCTION OF THE EVANSTON RODEO SERIES LIABLE FOR ANY INJURIES OR LOSS THAT I MAY SUSTAIN WHILE PARTICIPATING IN THE EVANSTON RODEO SERIES. I ALSO AGREE TO ABIDE BY ALL THE EVANSTON RODEO SERIES RULES AND REGULATIONS AND UNDERSTAND THE ALL ENTRY FEES ARE NON-REFUNDABLE. IF UPON WINNING OR PLACING IN ANY EVENT IT IS DETERMINED A PARTICIPANT NOT ELIGIBLE FOR THAT EVENT THAT PARTICIPANT WILL BE DISQUALIFIED AND NO PAYOUT ISSUED
